While at the Pentagon, Lt Col Kwasnoski served as Program Manager of two Air Force Operations and Maintenance budget systems: the Air Force Budget Execution and Analysis Tool (AFBEAT) and the Financial Analysis Consolidation and Translation Service (FACTS). Prior to that assignment, he served as the Financial Services Division Chief of Headquarters Pacific Air Forces. In addition, Lt Col Kwasnoski has served as installation financial controller twice, command compliance inspector, undergraduate professor, disbursing officer, budget officer and action officer. Additionally he has commanded two squadrons and deployed three times in support of combat operations.
